Beta = Covariance between portfolio returns and benchmark returns ÷ Variance of benchmark returns Alpha = Portfolio return – [Risk-free rate + (Beta × (Benchmark return – Risk-free rate))]


Information Ratio = (Portfolio return – Benchmark return) ÷ Tracking Error


